Request for information by Anna Borg Cardona on the Brocktorff family in Constantinople

I am a music researcher from Malta interested in the musical history of the Maltese Islands. At the moment I am working on a project involving a family of artist lithographers that left Malta for Constantinople in the early 1840s. The family's name was BROCKTORFF. They were best known for their maps and scenes of daily life in watercolour and lithography. However, before they left Malta they also printed music by lithography.

Several members of the family worked with the Protestant Church Missionary Society (CMS) in Malta for over 10 years until it closed down in 1842. They did all kinds of lithography for the CMS including works in Turkish, Arabic, Syriac etc.

The Brocktorffs had a great deal of experience in very diverse fields. I am trying to trace whether they set up in Constantinople on their own as a family business, or with another printing house, and especially whether they did any more music lithography while there.

I believe there was a connection with the Henri Cayol and Antoine Zellich printing house, but I am not entirely certain. I am looking for further information on this. I would love to know if you have any information whatsoever on the family while in Constantinople. Everything can be of help to me. The siblings in Constantinople were Federico, Luigi, Francesco and Leopoldo. Leopoldo arrived later, probably around 1871 for a short period.

Search for relatives and descendants, as well as a lost manuscript by Philipp Bernert

Dear descendants of the Levantines and dear friends of the Levantines,

I am a social and cultural anthropologist and I am searching for a lost manuscript for a research project, for which I am looking for contacts of relatives and descendants of various people from the Smyrna/Izmir area who might be able to help me in my search for the lost manuscript:

- * Auguste de Jaba (1801 in Vilnius 1894 in Smyrna/Izmir)
- * Auguste's son **Vladimir Joseph Nicolas Henri de Jaba** (1862 in Erzerum 1925 in Symrna/Izmir), as well as his wife **Nathali Sponti (or Sponty)** and their children **Marie (Marika) Aimée de Jaba** (1894 in Smyrna/Izmir), as well as her husband Morris Leland, married on 05 March 1917 in Smyrna/Izmir, **Vladimir Joseph Nicolas Henri de Jaba** (1862 in Erzerum 1925 in Symrna/Izmir), born on 05.03. 1917 in Smyrna/Izmir, **Joséphine Antoinette de Jaba** (1896 in Smyrna/Izmir), **Elena Amélie de Jaba** (1901 in Smyrna/Izmir), as well as her husband **Walther Thompson**, married on 23 December 1920 in Smyrna/Izmir, and **Ladislas Wladimir de Jaba** (1906 in Smyrna/Izmir)
- * Augustus' son of the same name **Auguste de Jaba** (1853 in Erzerum 1910 in Smyrna/Izmir), as well as his wife **Maria Elena de Cramer** (1874 in Smyrna/Izmir deceased), their children **Stanislas Wladimir de Jaba** (1901 in Smyrna/Izmir deceased) and **Nadège Maria de Jaba** (1906 in Smyrna/Izmir deceased)
- * Nadège Maria de Jaba's husband **François Husson** (1903 in Brussel -), whom she married on 24 August 1936 in Izmir, and their two children **Roland Husson**, and **Yves Marie Husson** (1937 in Izmir -), who married Marghareta de Borger
- * Maria Elena de Cramer's second husband Charles de Vries (1872 1943 Izmir)

The lost manuscript is entitled "Kitêba Tawârîkhê Cedîdê Kurdistan", which was completed by the Kurdish scholar Mahmud Bayazidi in 1858/59. He was commissioned to write this book by the Russian consul in Erzurum, Auguste de Jaba, who later moved to Smyrna/Izmir. The book describes the period between 1597 and its completion in 1858 almost 300 years later in around 1,000 pages.

In terms of content, the book focuses on the east of the Ottoman Empire and describes the history, narratives, social structures, social dynamics and conflicts of the various populations such as the Kurds, Yezidis, Armenians, Syriacs/Assyrians/Arameans, Turks, Greeks, Pontic Greeks and Jews.

The book, which is called "Book of the New History of Kurdistan" according to its translation, was written by Bayazidi in Kurmanji Kurdish in the Arabic alphabet. Auguste de Jaba also worked on a translation into French during his lifetime.

We know of the existence and content of the lost manuscript from a surviving translation of the preface, the table of contents and a description of the text by Auguste de Jaba, which he sent to the Scientific Academy in St. Petersburg in Russia in 1867.

Auguste's son Vladimir de Jaba sent the estate of his father Auguste's writings to the Scientific Academy in St. Petersburg in Russia in 1913. However, these writings did not include Bayazidi's Kurdish manuscript or the French translation of Auguste de Jaba's writings.

It was not found in the holdings of the Scientific Academy in St. Petersburg. The Russian orientalist and Kurdologist Yaklina Surenovna Musaelyan surmised during her lifetime that the book had never left Smyrna/Izmir. It is therefore possible that the Kurdish manuscript, as well as a French translation of the manuscript, are in the possession of Auguste de Jaba's descendants who remained in Smyrna/Izmir, or that they passed it on to other people, organisations or institutions in Turkey. Especially from the branch of Auguste de Jaba's son of the same name, Auguste de Jaba's wife Maria Elena de Cramer, their children Stanislas Wladimir de Jaba and Nadège Maria de Jaba, as well as their grandchildren Roland Husson and Yves Marie Husson can be traced back to the 1940s in Izmir.

A discovery of the book would be a very important source for the reconstruction and understanding of the history of the east of the Ottoman Empire, as well as the coexistence, dynamics and conflicts of its various population groups, such as the Kurds, Armenians, Turks, Syriacs/Assyrians/Arameans, Greeks. Jews, but especially the Yezidis. The Yezidis traditionally have an oral tradition of their history. Due to historical persecution, including the genocide of the Yezidis by the "Islamic State" in Iraq in 2014, there is a lack of traditions about periods of Yezidi history. A discovery of the lost book would provide important information for the reconstruction of Yezidi history.

In addition, the find would provide new insights into the Levantines, their social dynamics, global networks and important works.

Request for information by John Eric Chaplin on the life of Mr Robert Frew

I am researching the life of Mr Robert Frew DD OBE who was a missionary in Constantinople from 1902 and chaplain of the Anglican Church in Pera until 1924. Dr Frew lived in Pera for most of this time, travelling extensively and certainly coming into contact with the Levant community in Smyrna. He became quite well-known internationally following his work in the San Stefano cholera camp in 1912. He was accused of being a British spy during the war of independence, and, according to his own account, had close ties to the last Sultan. I would like to find out more about the background to these statements.

I have accessed quite a lot of material that is available on-line but I would be interested to know if there are other sources from non-digital or personal archives that might provide more information about the man himself.

One source that is not complete is the archive of the Bible House: The Orient newspaper. A lot of editions are available via the Digital Library for International Research but not all editions have been digitized. I wondered if members of the Heritage Foundation might know of other sources.

Without knowing the history of the Foundation I wondered if Dr Frew might have had some direct contact with the Foundation as he maintained a house in West Cromwell Rd in the 1920s and 1930s and probably had contact with the Levant community in London.

I don't want to restrict my questions too narrowly for fear of missing something interesting. There are many surprises in the history of Dr Frew.

My objective with this research is to write a book about Dr Frew together with a Turkish/Canadian research fellow.

Our messages

The Levantine Heritage Library & Archive

One of the three main aims of the LHF is to preserve Levantine heritage in its diverse forms (the other two being to promote research and education in Levantine studies). This includes family histories, images, databases, academic research – all of which can be found on our website. Our goal is also to collect and keep certain physical items such as books, family papers and photographs, recipes and cookbooks and any other item which can have a heritage or research value. Our ambition is one day to have a place, perhaps a Levantine house itself in need of preservation, where our library and collection can be preserved and made accessible.

We are happy to report that we have achieved a significant first step towards that ambition. We have established the Levantine Heritage Library and Archive. This is largely thanks to the significant legacy gifted of the library and genealogical research notes of the late Jacques Caporal. Our thanks go to Jacques's sons, Christophe, Fabrice and Gilles, who helped make this possible.

The Jacques Caporal Collection alone amounts to over 1,600 books and files on history, travelogues and family, church and diplomatic records. The earliest book in the collection was published over 400 yearsago. Amongst other 17th century books in the collection we have a copy of "Histoire de' Rè Lusignani" by Giovanni "Henrico" Francesco Loredano Giblet the Younger on the history of the Lusignan and Loredano families in Cyprus.

Most of the collection is in French, but includes items in English, Turkish, Greek, Arabic and 10 other languages. The general themes of the collection are the Levantine Catholic communities ("Latins"), their history and genealogies, France and the Levant and the travelogues of mainly French visitors to the Levant and the Middle east. There are also a significant number of books on Lebanon and Beirut, where Jacques Caporal lived for much of his life.





The collection of family trees and supporting church, state, diplomatic and trade documents is extensive. It is supported by records on disc and microfiche and probably the most comprehensive collection of images of tombstones and records of births, baptisms, marriages and deaths that exist for the Latin community. Tribute for this immense collection of records must also go to Jacques Caporal's friend and colleague, Marie Anne Marandet, who has also created a comprehensive online record of Levantine families on https://geneanet.org.

While the Jacques Caporal Collection currently comprises the majority of the Levantine Heritage Library & Archive, we also have smaller collections of other books and digital records in Turkey and the UK.



However, we are able to assist Members of the LHF with their own family researchby searching the Library catalogue for relevant names, extracting the records and providing the information we find. We give priority to LHF Members, but will assist others as best we can.




